Beginner Agility A (AGI-A) will be open to dogs that have not earned a UKC Beginner Agility title and other restrictions as set forth by UKC rules as of January 1, 2011.
Intermediate Agility A (AGII-A) will be open to dogs that have not earned a UKC Intermediate Agility title and other restrictions as set forth by UKC rules as of January 1, 2021

All Contacts and Table are rubberized non-slip surface. Floor is textured agility matting.

HURDLE HEIGHT DIVISIONS

Division Toy (4") – Dogs up to and including 10" at the withers
Division 1 (8") – Dogs over 10" & up to & including 14" at withers.
Division 2 (14") – Dogs over 14" & up to & including 20" at withers.
Division 3 (20") – Dogs over 20" at withers.

NOTICE TO EXHIBITORS

Due to Covid 19, we have to follow current state and city guidelines for “social distancing and cleaning. Masks are required in the building. “If you are concerned about the possibility of exposure to the coronavirus OR if you are unwilling to follow the current state and city rules, it would be best if you did not enter this trial.” More guidance will be sent to exhibitors closer to the trial.

There will be individual familiarization walk through on lead before the Beginner Agility and Intermediate Agility classes only for dogs entered in Beginner Agility A, Intermediate Agility A; and for Beginner Agility B and Intermediate Agility B dogs which have not earned the Beginner or Intermediate titles respectively and are not eligible to run in the A class.

Dogs may run with or without a collar. Slip collars, prong collars, or collars with tags are not permitted. Scored performances must be done off lead. If there are obstacles for which you have not trained, bypass them for safety's sake. To receive a qualifying score, dog and handler team must have successfully complete all obstacles.

A dog may be entered in Beginner Agility and Intermediate Agility classes at the same agility trial. However, titles will be awarded by UKC in sequence. If a dog meets all requirements for the Intermediate title, they must complete the Beginner title before the certificates or dog's record is updated by UKC.

No entry fees will be refunded after closing date unless entries can be replaced with wait list entries.

Bitches in season may not compete. CDST will refund one-half of class entry fees if veterinarian certification is received by trial secretary prior to start of trial. Full refund will be made if notified prior to closing date or entries can be replaced from the wait list.

Dogs must be under handler's control at all times.

Ample crating space is available. Crates may be left in the building overnight. No dogs may be left overnight.

Entry fees will not be refunded for dogs excused due to aggression.

No entry fees will be refunded if the trial cannot open or be completed by reason of riots, civil disturbance, fire, extreme &/or dangerous weather conditions, an act of God, public emergency or any cause beyond the control of Companion Dog Club of Tulsa or the show committee.

NOTE: No dogs under 8 weeks of age are allowed on trial site premises.

DIRECTIONS TO TRIAL SITE

From Highway 64/51 (Broken Arrow Expressway) take Memorial exit. Go south on Memorial to East 46th St (stop light). Turn east (left) onto 46th. At South 91st East Ave (US Post Office on N/W corner) turn north (left). Building is about ½ block on east side of street. L&M Office Furniture is right across the street.

From Interstate 44 take 41st St. exit. Go east on 41st St. to Memorial. Turn south (right) on Memorial and go to East 46th St (stop light). Turn east (left) onto 46th. At South 91st East Ave (US Post Office on N/W corner) turn north (left). Building is about ½ block on east side of street. L&M Office Furniture is right across the street.
