Show Hours

Building opens at 11:30 a.m. on Friday and at 7:45 a.m. on Saturday & 8:15 on Sunday

Pre-entries will be accepted on a "first received" basis beginning **Friday November 12, 2021**. No entries accepted prior to this date. Pre-entries will close **Friday, December 24, 2021**. Day of Show Entries for the trial on Friday will be accepted from 12:00 p.m.-12:30 p.m. Judging will begin at 1:00 p.m. Day of Show entries on Saturday will be taken from 8:00 - 8:30 a.m. Judging begins at 8:45 a.m. On Sunday, Day of Show entries are from 8:30-9:00 a.m. Judging will begin at 9:15 a.m.

Move-ups between trials will be permitted. The HD and Container trials will run from Novice up and back to back. Trial 1 Novice will be followed by Trial 2 Novice and then Trial 1 Advanced, etc. Interior trials will also run from Novice up to Elite but **not** back to back.

Pre-entry fee is \$20 (Jr. Handler \$10) per element. Day of Show entry fee is \$25 (Jr. Handler \$15) per element.

A fee of \$25.00 will be levied for a returned check. All entries must be submitted on **current** Official UKC entry forms, one dog per entry form. Unsigned, incomplete or illegible entries are not acceptable and will not be entered in the trial. FAX'd entries and/or credit card payments cannot be accepted. Entries sent by overnight mail must not require a signature. Entry cancellations will be accepted up until Friday, **December 24, 2021** and full refund of entries made. Move-ups or changes to entries will be accepted until entries close on December 24. Changes must be made to the Secretary by email or in writing. Entry fees will not be refunded in the event a dog is absent, disqualified, excused by judge or veterinarian, barred from competition by action of the show committee or UKC. No fees will be refunded if the show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency or any other cause beyond the control of the show committee. Refunds will be given for bitches that come in season after the closing date of the trial minus a \$5.00 handling fee with a veterinarian's certificate prior to the start of the trial.

Trial Information - Exhibitors

Novice title is required to enter the Advanced level. Advanced title is required to enter the Superior level. Superior title is required to enter the Master level. Master title is required to enter the Elite level.

The “A Division” of an element is open to any handler that has not earned a Nosework title in any organization or earned their title in that level of the element being entered and is not a Nosework judge or Nosework instructor.

Handlers are only allowed to run 1 dog per level in individual elements.

At the discretion of the judge, trial volunteers may run their dogs before other exhibitors as needed.

A UKC REGISTRATION NUMBER IS REQUIRED TO PARTICIPATE IN LICENSED TRIALS.
