**Awards:** Large rosette for High in Trial, High Combined and High Scoring Junior Handler in each trial. Ribbon for 1<sup>ST</sup>, 2<sup>nd</sup>, 3<sup>rd</sup>, and 4<sup>th</sup> in each class and for qualifying score. Additional prizes may be available day of trial. Special award offered to the highest scoring dog in Novice A or B in memory of Dianne Ree.

**Check-in Time:** Exhibitors should check in 30 minutes before scheduled start of class.

**Crating:** The building will be open Saturday and Sunday at 6:30 am for setup. Bring your own chair. Crates may be left overnight.

**Females In Season:** The host club has the option of refunding the entire entry fee or retaining up to 50% of the fee as a processing fee for any Obedience/ Rally trial competitor who provides a veterinarian's certificate verifying that the female came into season after the closing date for entries. The certificate may be mailed, provided the post-mark is no later than the date prior to the day of the trial, or delivered by hand to the Event Secretary before the published start time of the trial.

**Food:** Lunch will be provided to Judges and Volunteers at no charge. Exhibitors may purchase lunch for a fee of \$5.

A \$25.00 fee will be levied for a returned check. All entries must be submitted on Official UKC entry forms, one dog per entry form. Entry fees will not be refunded if the trial cannot open or be completed by reason of riots, civil disturbance, fire, extreme &/or dangerous weather conditions, an act of God, public emergency or any other cause beyond the control of Companion Dog Club of Tulsa or the show committee.
